Education - This program develops creative ways to share research and personal accounts in an effort to educate individuals on the harmful effects of pornography and its links to sex trafficking, in order to fulfill our mission and catalyze a youth-driven movement. We create and use resources on our website, educational documentary series, publications intended for the use of education and awareness, and our Presentation Program. In 2017, our Presentation Program reached an estimated total of 163,098 people through 247 total youth, adult, keynote, and community presentations.

Mobilization - This program transforms followers and passive observers, and empowers them to become advocates creating social change when it comes to pornography and all issues of sexual exploitation. We mobilize our movement through social media, community events, the Street Team, the Fighter App, the Fighter Club, and FTND apparel. We ended 2017 with over 1.45 million Facebook followers, over 117,000 Instagram followers, over 31,000 Twitter followers, over 29,000 Youtube subscribers, and in 2017 we had over 14.5 million website page views.

Recovery (Fortify) - Prior to this program's separation in September of 2017, this program worked to aid individuals struggling with pornography, using practical habit-breaking tools. We provided help to young people through a free online recovery program-purchaseable for adults-also accessible in a print version purchasable in our online store. The online Fortify Program reached over 70,000 total users from over 150 countries. During 2017, the Fortify recovery program assets were sold. The sale of these assets makes it possible for us to focus on our core mission of educating and raising awareness across the globe, it also eliminates the ongoing costs of maintaining and developing an online program in an ever-changing technological environment.
