Education - This program develops creative ways to share research and personal accounts in an effort to educate individuals about the harmful effects of pornography and its links to all forms of sexual exploitation, in order to fulfill our mission and catalyze a youth-driven movement. We create and utilize educational online resources including a youthful documentary series, awareness-raising sharable content and publications, and our Presentation Program. In 2018, our Presentation Program reached over 130,000 people through nearly 200 total youth, adult, keynote, and community presentations.

Mobilization - This program transforms followers and passive observers, and empowers them to become advocates creating social change with regard to the issues of pornography and sexual exploitation. We mobilize our movement through social media, community events, the Street Team, the Fighter Club, and conversation-starting apparel. We ended 2018 with over 3 million Facebook followers, over 132,000 Instagram followers, over 30,000 Twitter followers, and over 50,000 Youtube subscribers.
