Education - This program develops creative ways to share research and personal accounts in an effort to educate individuals about the harmful effects of pornography and its links to all forms of sexual exploitation, in order to fulfill our mission and catalyze a youth-driven movement. We create and utilize educational online resources including a youthful documentary series, awareness-raising sharable content and publications, and our Presentation Program. In 2019, our Presentation Program reached nearly 100,000 people through youth, adult, keynote, and community presentations. While our three-part documentary series was utilized for over 200 public screenings, and over 33,000 individuals created private viewing accounts to watch the series at home.

Mobilization - This program transforms followers and passive observers, and empowers them to become advocates creating social change with regard to the issues of pornography and sexual exploitation. We mobilize our movement through social media, community events, the Street Team, the Fighter Club, and conversation-starting apparel. We ended 2019 with over 5 million Facebook followers, over 164,000 Instagram followers, over 39,000 Twitter followers, and over 68,000 Youtube subscribers. Additionally, we launched a podcast in July of 2019 that had over 80,000 listens in 2019. We also had over 10 million website sessions from individuals educating themselves through our online resources.
