

We mobilize our movement through social media advocacy, our extensive blog library, the "Consider Before Consuming" podcast, our educational and "True Story" videos, and conversation-starting apparel. Our presence continues to grow and at the end of 2020, we had over 5.7 million Facebook followers, over 250,000 Instagram followers, over 53,000 Twitter followers, over 480,000 TikTok views, and over 100,000 YouTube subscribers. Additionally, our podcast has over 380,000 listens at the end of 2020. We also had over 9 million website sessions from individuals across the globe educating themselves through our online resources so they could turn around and help mobilize this movement.
